I. INTRODUCTION

II. IMPORTANT ITEMS

1. This meeting is to clarify general questions only. If there is a conflict between what was stated in this meeting and the bid documents, the bid documents shall govern. Any significant changes will be issued through an addendum. A copy of the meeting minutes will be issued to all attendees.
2. Deadline for questions is 2:00 p.m. HST on May 24, 2023. Questions and responses will be published on May 26, 2023.
3. Proposals due on June 9, 2023, at 2:00 p.m. HST.
4. The scope of work consists of replacing seven light poles and pedestals and recoating three existing light poles at Pier 1 at Hilo Harbor.
5. Only these 10 poles and pedestals that are being repaired/replaced/recoated for this project need to have new coating.

6. **All light fixtures and nodes will be reused and shall be reintegrated into the existing light grid network. The Contractor shall confirm the lights exist on the grid and are fully operational and functioning.**
7. **The Contractor shall coordinate with Matson, Inc. (Matson), regarding existing communication equipment mounted on light poles and pedestals. Removal and reinstallation of equipment will be performed by Matson.**
8. **The Contractor shall coordinate with the Harbors Hawaii District and the Harbors security surveillance system maintenance contractor regarding existing security equipment mounted on the light poles. Removal and reinstallation of equipment will be performed by the Contractor.**
9. The estimated cost is \$500,000 to \$800,000.
10. Key Information
 - a. Bidders must possess a valid State of Hawaii General Engineering Contractor's "A" license at the time of bidding.
