2. Roy announced that there are multiple sites of work and be aware that there is a summary sheet in the Proposal Schedule (P-20) that needs to be filled out.
3. Question: Is there any flow data for the Site that has the culvert lining work?
Response: No, we do not have any flow data.
4. Question: Is Protection of Roadway, Tree Trimming, Hauling of Spoils, etc. all included in the force account item? Suggestion made to change the pay items similar to the other Earthquake Project that has man-hours as the unit.
Response: We will consider this.
5. Question: For Slope Trimming/Scaling, the plans specify 3 week and the Special Provisions specify 4 weeks. Which is correct?
Response: Will clarify.
6. Question: Where is the shotcrete item for "Unreinforced" Soil Slopes? How do we estimate the quantity without cross-sections? Does the color need to be integrated into the shotcrete mix or other method? Is the shotcrete reinforced either by mesh or fiber? What is the strength requirement of the shotcrete? Is there a connection between the reinforced slope and the shotcrete?
