WITNESSETH: That for and in consideration of the payments hereinafter
mentioned, the CONTRACTOR hereby covenants and agrees with the STATE to
furnish, perform and/or deliver and pay for all labor, supplies, materials, equipment
and services called for in "KAAWALII GULCH TREE AND SHRUB TRIMMING,
HAWAII, PROJECT NO. 19H-02-04M", or such a part thereof as shall be required by
the STATE, the total amount of which labor, supplies, tools, materials, equipment and
services shall be computed at the unit and/or lump sum prices set forth in the
attached proposal schedule and shall be the sum ofEIGHT HUNDRED TWO
THOUSAND AND NO/100 DOLLARS ( \$802,000.00 ) as follows:
SUM OF ALL ITEMS\$802,000.00
which sum shall be provided from State funds, all in accordance with the
specifications, the special provisions, if any, the notice to bidders, the instructions to
bidders, the proposal and plans, if any, forProject No. 19H-02-04M, and any
supplements thereto, on file in the office of the Director of Transportation. These
documents, together with all alterations, amendments, and additions thereto and

deductions therefrom, are attached hereto or incorporated herein by reference and

made a part of this contract.

The CONTRACTOR hereby covenants and agrees to furnish, perform and/or deliver all labor, supplies, materials, equipment and services as provided herein within \_ ONE HUNDRED FIFTY ( 150 ) working days from the date of Notice to Proceed from the State.

For and in consideration of the covenants, undertakings and agreements of the CONTRACTOR herein set forth and upon the full and faithful performance thereof by the CONTRACTOR, the STATE hereby agrees to pay the CONTRACTOR the sum of <a href="EIGHT HUNDRED TWO THOUSAND AND NO/100">EIGHT HUNDRED TWO THOUSAND AND NO/100</a> DOLLARS (\$802,000.00) in lawful money, such payment to be made, subject to such additions hereto or deductions therefrom heretofore or hereafter made, in the manner and at the time prescribed in the specifications and this contract.

Extras as provided in the specifications may be allowed, in addition to said sum, in the amount of <a href="FORTY THOUSAND ONE HUNDRED AND NO/100">FORTY THOUSAND ONE HUNDRED AND NO/100</a> DOLLARS (<a href="#page-40.100.00">\$40.100.00</a>) in lawful money and shall be provided from State funds.

All words used herein in the singular number shall extend to and include the plural.

All words used in the plural number shall extend to and include the singular. The use of any gender shall extend to and include all genders.
