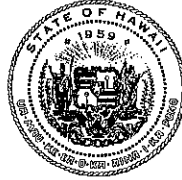

In accordance with the provisions of the Clean Water Act, Hawaii Revised Statutes, Chapter 342D; and Hawaii Administrative Rules, Chapters 11-54 and 11-55, Department of Health (DOH), the DOH has reviewed the following application for a National Pollutant Discharge Elimination System (NPDES) permit to discharge storm water run-off associated with construction activity:

The public notice of our proposed action was published in the *Hawaii Tribune-Herald* on **March 1, 2012**, regarding the above application.

After consideration of the expressed views of all interested persons and agencies, pertinent Federal and State statutes and rules regarding the discharge, the DOH hereby issues the enclosed NPDES permit for the discharge referred to above. This action does not constitute a significant change from the tentative determination set forth in the public notice.

This permit will take effect on **April 18, 2012**.
