Bids (hard copies) shall be submitted in a sealed envelope, and shall be on the Proposal Form provided on the compact disc furnished by said Department. Bids received after the established due date and time will not be considered.

The project includes reconstruction of weakened pavement and shoulders; removing, replacing and resetting of guardrail and replacing guardrail end treatments; installing gabion walls; and replacing traffic signs, markers and pavement markings. Estimated construction cost is between \$3,000,000 and \$6,000,000.

To be eligible for award, bidders must possess a valid State of Hawaii General Engineering Contractor's "A" license at the time bidding.

In accordance with Section 3-124-4, Hawaii Administrative Rules, this project is subject to Hawaii Product Preference. The Hawaii Product List may be examined at the State Procurement Office, 1151 Punchbowl Street or online at www.spo.hawaii.gov/hawaii-public-procurement-code-chapter-103d-hrs/alphabetical-list-of-qualified-applicants/.

All prospective bidders or their representatives (employees) are encouraged to attend, but attendance is not mandatory.
