BRIEF SUMMARY OF MEETING:

- 1. A brief overview of the project was presented.
- 2. The following announcements were made:
 - a. Item No. 312.0200, Hot Mix Asphalt Base Course, and Item No. 414.0100, Excavation of Weakened Pavement Areas, will be deleted from the project. (Reconstruction of weakened pavement areas will be done separately.) *Post Response: See Addendum No. 1.*
 - b. The Contractors' attention was called to Item No. 696.2000, Maintenance of Trailers, which is the new nomenclature for the provision of field offices as part of the project.
 - c. DBE goals were inadvertently omitted from the Special Provisions. This error shall be corrected by addendum. *Post Response: See Addendum No. 1.*
 - d. It is the intention of this project to carry the superelevations through the curves. The Contractor shall be required to level some areas in the field in order to match the typical section shown on the plans for superelevated sections.

3. Question: Why doesn't the State separate the asphalt quantities for pavement behind guardrails from the rest of the paving quantities?

Response: The State will consider separating the quantities.

Post Response: Asphalt quantities for paving behind guardrails have been separated, see Addendum No. 1.

4. Question: Why does the number of reconstructed centerline monuments differ between the Proposal Schedule and the Monument Schedule? Response: The numbers match up.

5. Question: Why is the monument at PT 569+87.36 being reconstructed, when it is outside of the project limits?

Response: The State will consider the question and respond in Addendum No. 1. Post Response: The monument at PT 569+87.36 has been deleted from the project, see Addendum No. 1.

6. Question: Is it the intention of the project for the Contractor to maintain every culvert shown per General Note No. 11 (incidental work)?

Response: The State will consider the question and respond in Addendum No. 1.

Post Response: General Note No. 11 has been deleted, see Addendum No. 1.

- 7. Question: The typical sections show 9-foot lanes with 3-foot shoulders, but the existing road isn't that wide in some places. Is it the intention of the project to widen the road? Response: No. The intention is to pave according to the typical section, but where there is no space (such as at narrow culvert locations), the Contractor is not expected to widen the roadway.
- 8. Question: How will shoulders be dressed?
 Response: There is a stockpile of cold-planed material located just outside of the project area, in the vicinity of Mile Marker 7, that is available for dressing of shoulders.
- Question: Won't the cold-planed material naturally slump down during the course of time, exposing the 30-degree pavement safety edge?
 Response: Yes, this is expected.
 Post Response: There is no need for the safety edge behind guardrails. See Addendum
- 10. Question: Are there any compaction requirements for the 30-degree pavement safety edge?

Response: No.

11. Question: There are no superelevation data or grade sheets provided in the plans, what guidance will be provided to the Contractors for carrying the superelevations through the curves?

Response: A State construction inspector or engineer shall be present on site to give guidance.

12. Question: Must the Contractor "block" pave each day, or can he work on one lane at a time?

Response: The answer is covered in the Standard Specifications for Road and Bridge Construction.

13. Question: Which governs the project, General Note No. 14 or the Standard Specifications for Road and Bridge Construction?

Response: The State will consider the question and respond in Addendum No. 1. Post Response: General Note No. 14 has been deleted, see Addendum No. 1.

14. Question: Can the Contractor substitute Mix No. V for Mix No. IV under guardrails? Response: Yes, the substitution may be permitted.

Post Response: The asphalt quantities for paving under guardrails have been separated out and specified as Mix No. V, see Addendum No. 1.

15. Question: Is all the AC Mix No. V noted in the proposal schedule intended to be used as a leveling course?

Response: Yes.

16. Question: The typical section shows a paved swale detail, however, there are areas in the field where there is no swale. What is the intention of the project? Response: The intention of the project is to pave whatever swale exists, regardless of whether the swale is paved or unpaved. It is not intended for the Contractor to grade new swales that do not already exist.

17. Question: Can the State check its total quantity of Asphalt Mix No. IV?
Response: The State will check and, if necessary, make adjustments via addendum.

Post Response: The quantities of Asphalt Mix No. IV and Asphalt Mix No. V have been adjusted, see Addendum No. 1.

18. Question: When are bids scheduled to be opened?

Response: June 23rd.

Post Response: The bid opening has been postponed to June 30th, see Addendum No. 1.
