- 2 That the quantities given in the attached proposal schedule are approximate only and are intended principally to serve as a guide in determining and comparing the bids
- 3 That the Department does not either expressly or by implication, agree that the actual amount of work will correspond therewith, but reserves the right to increase or decrease the amount of any class or portion of the work, or to omit portions of the work, as may be deemed necessary or advisable by the Director of Transportation, and that all increased or decreased quantities of work shall be performed at the unit prices set forth in the attached proposal schedule except as provided for in the specifications

- 4 In case of a discrepancy between unit prices and the totals in said Proposal Schedule, the unit prices shall prevail
- 5 Agrees to begin work within 10 working days after the date of notification to commence with the work, which date is in the notice to proceed, and shall finish the entire project within the time prescribed
- 6 The Director of Transportation reserves the right to reject any or all bids and to waive any defects when in the Director's opinion such rejections or waiver will be for the best interest of the public
