CONTRACT

THIS AGREEMENT, made this $2^{\mu\nu}$ day of <u>Approx</u>, <u>2000</u>, by and between the STATE OF HAWAII, by its Director of Transportation, hereinafter referred to as "STATE", and <u>AINA SITE CONSTRUCTION, INC.</u> whose business/post office address is <u>3175 Elua Street, Suite B, Lihue, Hawaii 96766</u> hereinafter referred to as "CONTRACTOR";

WITNESSETH: That for and in consideration of the payments hereinafter mentioned, the CONTRACTOR hereby covenants and agrees with the STATE to complete in place, furnish and pay for all labor and materials necessary for "KAUMUALII HIGHWAY DRAINAGE IMPROVEMENTS, VICINITY OF MAHINAULI BRIDGE, KAUAI, PROJECT NO. 50B-01-04", or such a part thereof as shall be required by the STATE, the total amount of which labor, material and construction shall be computed at the unit and/or lump sum prices set forth in the attached proposal schedule and shall be the sum of <u>THREE HUNDRED THIRTY SEVEN THOUSAND</u> <u>FOUR HUNDRED SIXTY AND NO/100</u> DOLLARS (<u>\$337,460.00</u>) as follows:

SUM OF ALL ITEMS.....\$337,460.00

which sum shall be provided from State funds, all in accordance with the Hawaii Standard Specifications for Road, Bridge, and Public Works Construction, 1994, or such other standard specifications as may be provided for specifically herein, the special provisions, the amendments to special provisions, if any, all of which are hereinafter referred to as "specifications", the notice to bidders, the instruction to

bidders, the proposal and plans for Project No(s) <u>50B-01-04</u>, and any supplements thereto, on file in the office of the Director of Transportation. These documents, together with all alterations, amendments, additions and deductions thereto or therefrom, are attached hereto and/or incorporated herein by reference and made a part of this contract.

The CONTRACTOR hereby covenants and agrees to complete such construction within <u>FIFTY</u> (50) working days from the date indicated in the notice to proceed from the STATE subject, however, to such extensions as may be provided for in writing under the specifications.

The CONTRACTOR further agrees to execute the attached "Certification of Compliance for Final Payment" form prior to payment of the final estimate by the STATE.
