Amend the Bid Documents as follows:

#### 1. PLANS

- a. Revise General Note No. 6 on Plan Sheet No. 3 General Notes to read as follows:
  - "6. The Contractor shall provide for and maintain access to and from all existing sidewalks, ADA access routes complying with ADAAG Section 4.3 and cross streets at all times. This work shall be considered incidental to the various contract items and will not be paid for separately."
- b. Revise General Note No. 25 on Plan Sheet No. 3 General Notes to read as follows:
  - "25. Pursuant to HRS Chapter 6E, in the event any artifacts or human remains are uncovered during construction operations, work in the vicinity of the find shall be suspended immediately and the area cordoned off. Immediately notify Kauai Police Department, State Department of Land and Natural Resources-Historic Preservation Division (ph. 652-1510 and 742-7033 on Kauai, and 692-8015 headquarters on Oahu), and the State's Engineer."
- c. Delete Note No. 13 under General Notes for Traffic Control Plan on Plan Sheet No. 5 Construction, Traffic and Utility Notes.

Following are the questions and responses discussed at the pre-bid meeting:

1. Is the Contractor required to submit a "Notice of Intent to Bid"?

No. Notice of Intent is not required.

2. When will construction begin?

As stated in Section 103.02 of the Special Provisions, the contract will be awarded within 60 calendar days after the opening of the bids. Construction should follow.

3. DOT Comment:

See Plan Sheet No. 5, Note No. 1 of Notes for Construction in State ROW. Note the hours of lane closures that will be allowed.

4. DOT Comment:

See Plan Sheet No. 5, Note No.2 of Notes for Construction in State ROW. As a new requirement, the Contractor must obtain a construction permit from the State's Highway District Engineer.

5. Will the work at Mile Post 11.3 be phased to allow for vehicle traffic through Anuhea Street?

Yes. Anuhea Street is a low traffic residential type driveway. Contractor should provide access during construction, as required by Note No. 6 on Plan Sheet No. 3.

6. DOT Comment:

The Contractor should submit site specific BMP plans to the State Highways, Kauai District as required by Section 209.3 of the Standard Specifications.
