**The project includes roadway excavating; hydro-mulch seeding; constructing right turn lane; removing existing railing, curbs, and sidewalk; installing new railing, curbs, sidewalk, traffic signs and pavement markings; grading and relocating telephone pole.** Estimated construction cost is between \$ 500,000 and \$ 1,000,000.

To be eligible for award, bidders must possess a valid State of Hawaii General Engineering Contractor's "A" license at the time of bidding.
