#### A. SPECIAL PROVISIONS

1. Replaced Section 107 – Legal Relations and Responsibility to the Public dated 7/01/08 with the attached Section 107 - Legal Relations and Responsibility to the Public dated r6/02/10.

## B. PLANS

- 1. Amend Plan Sheet No. 3 General Notes and Legend by revising General Notes No. 7 and 11 to read as follows:
  - "7. All lanes shall be open to traffic during the hours from 6:30 A.M. to 8:00 P.M., Only one lane of highway shall be closed at any other time. Night time working hours are specified in Section 107 of the Special Provisions. Failure of the contractor to open all lanes of traffic during the times specified above shall result in assessment of liquidated damages as specified in Section 108.09 of the Special Provisions."

- 11. Trimming and dressing of shoulder, sidewalk, and bus turnout shall consist of clearing, grubbing, grading, reshaping and compacting the unpaved shoulder with suitable material as shown on the plans and/or as directed by the engineer. Suitable materials shall include materials from roadway excavation, including topsoil and base material therefrom, and if necessary, additional materials from borrow outside the limits of the right of way. Asphalt concrete removed from cold planing, reconstruction and roadway excavation shall not be used for dressing of shoulder, sidewalk or bus turnout. Hydro-mulch all areas of shoulder that has been dressed. This work shall be considered incidental to the various contract items."
- 2.. Replace Plan Sheet No. 6 with attached Plan Sheet No. ADD.6.

The meeting started at 9:00 A.M. Project Manager Stanford Iwamoto began the meeting with introducing the participants from HDOT and a brief overview of the background and scope of work.

The following question was raised at the meeting:

Question # 1: General Note No. 7 of Plan Sheet no. 3, states that all lanes shall be open to traffic during the hours of 6;30 A.M to 8:00 P.M. Since lane closures will only be allowed at night, what are the hours allowed for night work?

**Response:** HWY-K will amend General Note No. 7 of Plan Sheet No. 3 and Section 107 of the Special Provisions to call out night work.

Question # 2: Reference to General Note No. 17 of Plan Sheet No. 3, will the contractor be required to correct ponding areas?

**Response:** Yes, Contractor have to fix the water ponding. HWY-K reiterated subsection 401.03(I) – HMA Pavement Surface and Thickness Tolerances.

**Question # 3**: Will all shoulder areas that are dressed by the contractor need to be hydromulched?

**Response:** Yes, hydro-mulch all shoulder that are scheduled to be dressed and this work shall be considered incidental to various contract items. HWY-K will amend General Note No. 11 of Plan Sheet No. 3.

Question # 4: Asphalt concrete materials from cold planing, reconstruction, and roadway excavation will have to be delivered to the Lihue Airport at night. Is there a need to provide private security at the disposal site?

Response: Highways will check with airports Division. (Follow-up information. Highways did check with Airports and at this time there is no requirement to provide private security at the Disposal Site.

There were no other questions or comments.

With no further questions or comments, the pre-bid meeting was adjourned at 9:30 A.M.
