NOTICE TO BIDDERS (Chapter 103D, HRS)

The receiving of SEALED BIDS for Eleele Pedestrian Overpass Improvements Project No. 50C-01-19M, will begin as advertised in HIEPRO. Bidders are to register and submit bids through HIEPRO only. See the following HIEPRO link for important information on registering: <https://hiepro.ehawaii.gov/welcome.html>.

Deadline to submit bids is – Friday, October 30, 2020, at 2:00 P.M., Hawaii Standard Time (HST).

Bids received after said due date and time shall not be considered.

The scope of work consists of removing the portion of the bridge superstructure bearing upon the steel bents; and replacing with new concrete stairs, deck, girders, beams, and railings, and repairing spalled concrete. The new superstructure shall be raised in elevation in order to avoid future vehicle impact to the girders. The estimated cost of construction is between \$750,000 and \$1,000,000.

To be eligible for award, bidders must possess a valid State of Hawaii General Engineering Contractor's "A" license at the time of bidding.

The Hawaii Products Preference pursuant to Section 103D-1002, Hawaii Revised Statutes (HRS), is applicable to this project. Persons wishing to certify and qualify a product as a Hawaii Product shall submit a Certification for Hawaii Product Preference (SPO) Form 38 to the Department of Transportation (DOT) Contracts office no later than 4:30 P.M., fourteen (14) calendar days prior to the bid opening date. Late submittals for this project will not be reviewed by the DOT. A separate SPO-Form 38 shall be completed and submitted for each product. Forms are available at <http://spo.hawaii.gov/all-forms/>.

A 5% bid adjustment for bidders that are parties to apprenticeship agreements pursuant to Section 103-55.6, HRS, is applicable to this project.

Compliance with Act 192, SLH 2011 is a requirement for this project whereby a minimum of 80% of the bidder's work force on this project **must** consist of Hawaii residents.

A pre-bid conference is scheduled for October 14, 2020, at 9:00 A.M. HST. All prospective bidders or their representatives (employees) are encouraged to attend, but attendance is not mandatory. **Due to the impacts of COVID 19, the pre-bid meeting will be conducted virtually.**

ALL requests for information shall be received in writing via HlePRO no less than 14 calendar days before bid opening. Questions received after the deadline will not be addressed. Verbal requests for information will not receive a response. Anything said at the conference is for clarification purposes and any changes to the bid documents will be made by addendum and posted in HlePRO.

Any protest of this solicitation shall be submitted in writing to the Director of Transportation, in accordance with §103D-701, HRS and §3-126, HAR.

Campaign contributions by State and County Contractors. Contractors are hereby notified of the applicability of Section 11-355, HRS, which states that campaign contributions are prohibited from specified State or county government contractors during the term of the contract if the contractors are paid with funds appropriated by a legislative body. The Equal Employment Opportunity Regulations of the Secretary of Labor implementing Executive Order 11246, as amended, shall be complied with on this project.
