## **CONTRACT**

THIS AGREEMENT, made this <u>10th</u> day of <u>July</u> , 2003,
by and between the STATE OF HAWAII, by its Director of Transportation, hereinafter
referred to as "STATE", andJAS. W. GLOVER, LTD whose business/post office
address is P.O. Box 579, Honolulu, Hawaii 96809 hereinafter referred to as
"CONTRACTOR";
WITNESSETH: That for and in consideration of the payments hereinafter
mentioned, the CONTRACTOR hereby covenants and agrees with the STATE to
complete in place, furnish and pay for all labor and materials necessary for
"KAUMUALII HIGHWAY RESURFACING, LAWAI BRIDGE TO HALEWILI ROAD,
KALAHEO, KAUAI, PROJECT NO. 50C-01-01M", or such a part thereof as shall be
required by the STATE, the total amount of which labor, material and construction

shall be computed at the unit and/or lump sum prices set forth in the attached proposal schedule and shall be the sum of <u>ONE MILLION FIVE HUNDRED</u>

SEVENTY SIX THOUSAND ONE HUNDRED AND NO/100 DOLLARS

(\_\$1,576,100.00 ) as follows:

SUM OF ALL ITEMS.....\$1,576,100.00

which sum shall be provided from the following funds:

Total.....\$1,576,100.00

State funds, all in accordance with the Hawaii Standard Specifications for Road,

Bridge, and Public Works Construction, 1994, or such other standard specifications as may be provided for specifically herein, the special provisions, the amendments to special provisions, if any, all of which are hereinafter referred to as "specifications", the notice to bidders, the instruction to bidders, the proposal and plans for Project No(s) 50C-01-01M\_\_, and any supplements thereto, on file in the office of the Director of Transportation. These documents, together with all alterations, amendments, additions and deductions thereto or therefrom, are attached hereto and/or incorporated herein by reference and made a part of this contract.

The CONTRACTOR hereby covenants and agrees to complete such construction within <u>ONE HUNDRED</u> (100) working days from the date indicated in the notice to proceed from the STATE subject, however, to such extensions as may be provided for in writing under the specifications.

For and in consideration of the covenants, undertakings and agreements of the CONTRACTOR herein set forth and upon the full and faithful performance thereof by the CONTRACTOR, the STATE hereby agrees to pay the CONTRACTOR the sum of ONE MILLION FIVE HUNDRED SEVENTY SIX THOUSAND ONE HUNDRED AND NO/100 DOLLARS (\$1,576,100.00) in lawful money, but not more than such part of the same as is actually earned according to the STATE's determination of the actual quantities of work performed and materials furnished by the CONTRACTOR at the unit or lump sum prices set forth in the attached proposal schedule. Such payment, including any extras, shall be made, subject to such additions or deductions hereto or hereafter made in the manner and at the time prescribed in the specifications and this contract. In any event, extras shall not exceed SEVENTY EIGHT THOUSAND EIGHT HUNDRED FIVE AND NO/100 DOLLARS (\$78,805.00) in lawful money and shall be provided from State funds.

All words used herein in the singular shall extend to and include the plural. All words used in the plural shall extend to and include the singular. The use of any gender shall extend to and include all genders.
