

**MINUTES OF THE PRE-BID MEETING

MINUTES OF THE MEETING:

1. The meeting started at 9:00 A.M., at the conference room of the State Highways Division, on March 29, 2005.
2. The meeting was attended by 2 staff members of Niu Construction, Inc., 1 staff member of Sun Industries, Inc., and 2 staff members of State Highways Division, Kauai District (HWY-K). See attached Pre-Bid Conference Attendance List.
3. HWY-K told the pre-bid meeting participants that the winning bidder shall submit BMPs plan directly to the HWY-K's Construction Engineer. HWY-K will submit the BMP's plan to the State Department of Health.
4. Clarification sought whether existing guardrails will be adjusted or not. HWY-K indicated that all existing guardrails will not be adjusted.
5. Clarification sought whether the directional signs will be constructed with extruded aluminum panels or one-sheet flat panel. HWY-K indicated that directional signs shall be constructed with one-sheet flat panel.
6. HWY-K noted that there are minor discrepancies between the pavement marking plans and the traffic summaries sheet. HWY-K instructed the contractors to bid according to the proposal schedule, and adjustments or corrections to the discrepancies will be made during project construction.
7. With no further questions/comments, the pre-bid meeting was adjourned at 9:45 A.M.
