The project includes reconstructing weakened pavement areas; cold planing; resurfacing; adjusting telephone and traffic signal pullboxes and/or manholes, water valve boxes and street survey monuments; adjusting and/or installing grated drop inlets, centerline and reference survey monuments, and loop detector sensing units; repairing bridge joints; removing and installing pavement markings and traffic signs; and dressing of shoulders.

To be eligible to bid, bidders must possess a valid State of Hawaii General Engineering Contractor's "A" license.


Each proposal shall be on a form furnished by said Department.
