- a. **RFI N0 1:** Is there attendees list from the pre-bid meeting?

Response: Pre-Bid Meeting attendance list is included in Addendum No. 1.

- b. **RFI N0 2:** Title of the plans have KUHIO HIGHWAY RAISED CROSSWALK, VICINITY OF CARL FURUTANI STREET, can you please clarify

Response: Revised title of the plans is included in Addendum No. 1

- c. **RFI N0 3:** Can you please clarify the pay items for the signs. There are only 6 posts with signs (with Type V Object Markers) and there are 2 warning signs less then 10 SF without posts on sheet 7? This does not match the pay items for 631.0200 and 632.1050. Also there needs to be an added pay item for warning sign with out post.

Response: Revised Proposal Schedule is included in Addendum No. 1.

- d. **RFI N0 4:** Can asphalt cement PG 64-16 binder be used for the speed bump and any A.C. surface patching for this project?

Response: Yes, PG 64-16 can be used.

- e. **RFI N0 5:** Will a pavement smoothness rideability test be required? Is 401.03(M) through 401.03(S) applicable for this project?

Response: A pavement smoothness rideability test will not be required on this project. 401.03(M) through 401.03(S) are not applicable to this project.

- f. **RFI N0 6:** Can SS-1h be used instead of the pavement joint adhesive in 401.03(L)?

Response: Joint adhesive must be used as specified in 401.03(L). SS-1h will not be allowed as a substitution.
