The meeting started at 9:00 A.M. Fred Reyes began the meeting with a brief overview of the background and scope of work.

The following was raised at the meeting by HDOT:

HDOT informed that major construction activities shall be done at night. Refer to Section 107 - Legal Relations and Responsibility to Public of the Special Provisions regarding working hours and noise variance.

The following question (RFI's) was received by HDOT before the meeting:

Question # 1: Per Plan Sheet No. 9, can you verify the reconstruction limits and section for this project?

Response: As called out on Plan Sheet No. 9, the reconstruction limits and sections for reconstruction areas are Sta. 106+55 to Sta. 196+00 for Wilcox Road to Lala Road and Sta. 196+00 to Sta. 6+85 for Lala Road to Halau Street. These reconstruction limits will be revised via an addendum.

The following question was raised at the meeting:

Question # 1: Per second paragraph of Section 671.03 (A)(c), - Training classes shall be taught by authorized representatives of the U.S. Fish and Wildlife Service, the Department of Land and Natural Resources, the Save Our Shearwater program or other qualified personnel accepted by the Engineer. Can the Contractor attend training classes on Oahu?

Response: Yes, the Contractor can attend training classes on Oahu or Neighbor Island as long as the Contractor will furnish the Engineer with evidence that the Contractor has held training classes, including the dates of the classes, identify who conducted the training, and the the content and nature of the training.

The following questions (RFI's) were received by HDOT after the meeting:

Question # 1: Per Proposal Schedule on the Special Provisions, Item No. 630.0130 – Street Name Sign calls out three (3) units are to be installed on this project. Although the details for all three street name signs are shown on Plan Sheet No. 19, none of the other two street name signs are called out on the plans. Confirm if all of the street name signs are to be installed on stop signs.

Response: This will be clarified via an Addendum.

Question # 2: Proposal Schedule on the Special Provisions, Item No. 631.0120 – Regulatory Sign (10 Sq. Ft. or Less) calls out for two (2) units of these signs to be installed. Provide details for these two signs as well as their locations on the project.

Response: Per Plan Sheet No. 18, two (2) units of “Do Not Enter” sign (R5-1) (30”x30”) shall be installed at the back of each of the two (2) new “Yield” sign with post located at the intersection of Rice Street and Kapule Highway.

Question # 3: Per Proposal Schedule on the Special Provisions, Item No. 632.0110 – Reflector Marker (RM-2) calls out for twenty three (23) units of these reflector marker are to be installed on this project. Confirm on the plans where and what these reflector marker are to be installed on.

Response: This will be clarified via an Addendum.

With no further questions or comments, the pre-bid meeting was adjourned at 9:30 A.M.

The minutes of the meeting will be distributed in Addendum No. 1 to the Contract Plans. Contractors will be notified when addendum will be available for pick up.
