Question #1: What is the potential start date of the contract?

Question #1: Which line item on the proposal schedule should the excavation line item go into? There is no excavation line item listed on the current proposal schedule.

Response: Excavation works shall be considered incidental to various contract item.

Question #2: For the 4" aggregated bedding of the new concrete curb, should the scope and materials go into the 638.2000 Curb, Type 2D item or 304.0100 Aggregate base line item?

Response: This work shall be considered incidental to Item No. 638.2000 – Curb, Type 2D.
