Bids (hard copies) shall be submitted in a sealed envelope, and shall be on the Proposal Form provided on the compact disc furnished by said Department. Bids received after the established due date and time will not be considered.

The project includes demolishing existing highway facilities; excavating, cold planing existing pavement; constructing sidewalks, curbs and gutters; constructing new asphalt pavement section; installing new curb ramps; adjusting utility manholes, cleanouts, water valves, etc. to grade; removing and installing pavement markings and traffic signs; relocating a water service and sewer cleanout; and modifying existing

traffic signal. Estimated construction cost is between \$500,000 and \$1,000,000.

To be eligible for award, bidders must possess a valid State of Hawaii General Engineering Contractor's "A" license at the time of bidding.

In accordance with Section 3-124-4, Hawaii Administrative Rules, this project is subject to Hawaii Product Preference.
