Kuhio Highway Short-Term Improvements, Waialua, Kauai

Dear Mr. Sato:

We are in receipt of your letter dated October 11, 2007, in which you request information concerning the proposed Kuhio Highway improvements. We received your letter on October 15, 2007. The proposed action includes the addition of one southbound lane between mileposts 5.8 and 6.6. The southern terminus is at the intersection of Kuhio Highway with Kuamoo Road. The northernmost extent of the project is at the intersection of Kuhio Highway and the Temporary Bypass Road. The proposed project will widen the highway from three to four lanes. Existing street lights will be relocated and three new street lights will be added. Improvements will also be made to Kuamoo Road using private funds.

We have reviewed the information you provided regarding the proposed project. We request that you prepare a biological assessment accordance with section 7 of the Endangered Species Act of 1973, as amended (16 U.S.C. 1531 et seq.) to address potential impacts of this project on the federally endangered Hawaiian coot (Fulica alai), Hawaiian duck (Anas wyvilliana), Hawaiian common moorhen (Gallinula chloropus sandvicensis), Hawaiian stilt (Himantopus mexicanus knudseni), Hawaiian hoary bat (Lasirus cinereus semotus), Hawaiian petrel (Pterodroma phaeopygia sandwichensis) and the threatened Newell's shearwater (Puffinus auricularis newelli). We suggest that you include the following as outlined in the regulations governing interagency consultations (50 CFR §402.14(c).

- 1. A description of the action to be considered.
- 2. A description of the specific area that may be affected by the action.
- 3. A list of threatened or endangered species or critical habitat that may be affected by the action.

4. A description of the manner in which the action may affect any listed species or critical habitat and an analysis of cumulative impacts.

- 5. Relevant reports related to the project, such as an environmental impact statement, environmental assessment, or biological assessment.
- 6. Any other relevant available information on the action, the affected listed species, or critical habitat.

The Federal Highways Administration (FHA) will need to determine whether or not their action may affect any listed species. If FHA makes the determination that their actions may affect listed species, they are required to inform the Service in writing. If FHA determines that their actions may affect listed species but are not likely to adversely affect them because the impacts to species are insignificant, discountable, or wholly beneficial, then FHA must request the Service's written concurrence with their finding. Upon receiving written concurrence, Endangered Species Act consultation requirements will be concluded. However, if FHA determines that their actions may adversely affect listed species, or the Service does not concur that FHA's actions are not likely to adversely affect listed species, FHA will need to request formal consultation.
