The meeting started at 9:00 A.M. Project Engineer Bernie Vargas began the meeting with a brief overview of the background and scope of work.

HDOT opened the floor to questions. It was noted that the questions and responses to the questions would be included in an addendum.

Question # 1: On Plan Sheet No. 8, Typical Pavement Edge Detail, does the Contractor need to clear the top soil adjacent to the edge of shoulder (e.s.)?

Response: Yes, the Contractor needs to remove and dispose topsoil adjacent to the edge of shoulder. The exposed subgrade should be properly recompacted to dense and unvielding conditions before placement of safety edge.

The following RFI's (Request for Information) were received by HDOT thru email after the meeting:

RFI # 1: Bid Item No. 632.0210 - Type II Object Marker (OM-2H), these are not shown on the plans and we want to confirm that these will be installed on existing trees or utility poles. If not, provide details on the installation of these markers.

Response: Per Note No. 25 of Plan Sheet No. 3 - General Notes & Legend, Type II Object Marker (OM-2H) shall be installed on all utility poles and trees that are shown on Plan Sheets No. 17 thru 20 - Pavement Marking & Traffic Signing Plan. Refer to Standard Plan TE-15, Highways Division, Design Branch, 2008 for details.

RFI # 2: Plan Sheet 23 - Low Speed Undivided Highway Work Zone Signing Plan, Notes & Details shows the standard work zone signing require two (2) sets of signs on each end of the project. Confirm how many sets of these signs are required. Are these signs required on each of the side streets which intersect the work zone?

Response: Construction sign assemblies shall be installed on both the approaching and trailing end of the project as shown on Plan Sheet No. 23 – Low Speed Undivided Highway Work Zone Signing Plan. For traffic control plan/signs on side streets that intersect the work zone, refer to attached Traffic Control Plan (page 3).

With no further questions or comments, the pre-bid meeting was adjourned at 10:00 A.M.

The minutes of the meeting will be distributed in Addendum No. 1 to the Contract Plans. Contractors will be notified when addendum will be available for pick up.
