# A. REQUEST FOR PROPOSAL

**a.** Revise the 8<sup>th</sup> paragraph of the Request for Proposals legal notice with the following paragraph:

"Step-II: Submission of design concept documents and a price proposal. The top three Proposers shall submit proposals (design concept documents and prices) to the Contracts Office no later than June 13, 2013. Additionally, HDOT may conduct interviews with each Proposer to provide the Proposer an opportunity to present their design concept and to answer any questions HDOT may have.

A stipend payment of \$20,000 will be paid only to the non-selected, second and third ranked, qualified Proposers for submitting a complete proposal under Step-II. If the stipend is accepted by the Proposer, they forgo any rights to challenge the process."

   <u>Response:</u> Because this is Design Build Project a DBE Goal is not specified
- What is the date for RFI's?
   Response: See Section V.2. Requests for Information on TP-63 of the Technical Provisions
- 3. Does the Quality Control Plan count toward the 100-page limit? Response: Yes.
- 4. Are As-Built available?

  <u>Response</u>: The As-Built plans, Pavement Justification Report, and Categorical Exclusion documents will be provided on CD at the end of this meeting.
- Is there a soils report available?
   <u>Response</u>: Soils information is provided as part of the Pavement Justification
   Report. There is no separate soils investigation report'
- 6. Is there a requirement to remove the existing concrete median?

  Response: The removal of the concrete median is an item of work that should be considered but does not have to be included in the Proposer's scope of work.
- 7. Is there a preliminary drainage report available? Is the drainage report for the Kaumualii Highway Widening Project Available?

  Response: There is no preliminary drainage report for this project. We are checking to see if the drainage report for the Kaumualii Highway Drainage report is available and if it is, it will be provided to all prospective Proposers.
