**The project includes reconstructing weakened pavement areas; cold planing existing pavement; resurfacing; removing pavement markings and traffic signs; installing pavement markings, traffic signs and centerline and reference survey monuments; replacing curbs, gutters and grated drop inlets; constructing grouted rubble paving; and dressing shoulders.**

Plans and specifications may be examined and borrowed at the appropriate offices. Borrowed plans and specifications shall be returned in good condition within 30 calendar days after the bid opening date.

To be eligible to bid, bidders must possess a valid State of Hawaii General Engineering Contractor's "A" license.

Bidder's notice of intention to bid must be received at said Contracts Office no later than 4:30 P.M., 10 calendar days prior to the bid opening date. If the tenth day is on a Saturday, Sunday or State holiday, the notice of intention is due on the last working day prior to the due date. Fax notice is acceptable provided the Contracts Office receives the faxed notice within the time stated above. The fax number is (808) 587-2132. It is the bidder's responsibility to ensure that the Contracts Office receives the notice of intent on time and in a legible condition.

A pre-bid conference is set for November 19, 2003, at 9:00 a. m., at the Department of Transportation, Highways Division, 601 Kamokila Boulevard, Room 111 A/B, Kapolei, Hawaii 96707. All prospective bidders or their representatives (employees) are encouraged to attend, but attendance is not mandatory.


