




GENERAL NOTES FOR TIEBACK WALL

- Shotcrete shall develop a minimum 28 day compressive strength of 4,000 psi.
- 2. Concrete shall develop a minimum 28 day compressive strength of 4,000 psi.
- 3. Tieback grout shall develop a minimum compressive strength of 3,000 psi prior to stressing. Testing for compressive shall conform to ASTM C-109.
- 4. All reinforcing bars shall be grade 60 and comply with ASTM A615. Welded Wire Fabric (WWF) shall conform to ASTM A497. WWF shall be furnished in sheets and galvanized after fabrication.
- 5. See Sheet S-5 for Tieback Details and requirements.
- 6. Unless otherwise noted, all exterior corners and edges shall have 3/4" chamfers. All interior corners shall have 3/4" fillets.
- The Contractor is responsible for providing and maintaining stable slopes below the New and existing walls during the construction period.
- 8. Design soil parameters for Tiebacks shall be based on the soils report prepared by Geolabs, Inc. dated August 17, 2004 and December 30, 2004 and modified in Geolab's memorandum dated February 8, 2005.

- non existent. core New 4" Dia. weep Holes. Weep holes shall be spaced at 6'-4"o.c. maximum. The Weep Hole at face of New Wall shall be loacted 6" to 9" above final grade. If existing weep holes exceed 6'-4"o.c. spacing, add New Weep Holes. Weep Holes shall be located no closer than 18" from bottom layer of Tiebacks.
- 10. Where a single Tieback Wall is resting on underlying basalt rock foundations, #4x36" dowels shall be grouted 12" into the rock and embedded 24" into the shotcrete wall. Spacing of dowels shall be at 24" on centers unless otherwise determined by the Engineer.







If rocks are large and removal would result in large oversized holes:

First chip back rock to the proper depth (See Email of 12/3/2007). Install PVC insert and grout. Place guardrail post as shown in contract drawings.





If rocks are small and loose:

Remove rocks in the vicinity of the post location to the proper depth. Place an 8"ø or 10"ø PVC pipe and grout area around post. Insure grout is properly consolidated around insert and loose rocks around area of the post.






TYP. SINGLE LAYER TIEBACK WALL SECTION


SINGLE LAYER TIEBACK WALL
SECTIONS




