**The project includes reconstructing weakened pavement areas; cold planing existing pavement; pavement widening; resurfacing; removing and/or adjusting existing guardrails; installing new metal guardrails; constructing concrete end posts and aesthetic railings; removing and installing pavement markers and traffic signs; pavement striping; cleaning existing drainage systems; and dressing of shoulders.**

Plans and specifications may be examined and borrowed at the appropriate offices. Borrowed plans and specifications shall be returned in good condition within 30 calendar days after the bid opening date.

A pre-bid conference is set for November 19, 2003, at 9:00 a. m., at the Department of Transportation, Highways Division, 601 Kamokila Boulevard, Room 111 A/B, Kapolei, Hawaii 96707. All prospective bidders or their

representatives (employees) are encouraged to attend, but attendance is not mandatory.

To be eligible to bid, bidders must possess a valid State of Hawaii General Engineering Contractor's "A" license.

Bidder's notice of intention to bid must be received at said Contracts Office no later than 4:30 P.M., 10 calendar days prior to the bid opening date. If the tenth day is on a Saturday, Sunday or State holiday, the notice of intention is due on the last working day prior to the due date. Fax notice is acceptable provided the Contracts Office receives the faxed notice within the time stated above. The fax number is (808) 587-2132. It is the bidder's responsibility to ensure that the Contracts Office receives the notice of intent on time and in a legible condition.


