## GENERAL NOTES

- 1. The scope of work for this project includes reconstructing weakened pavement areas; cold planing; resurfacing; adjusting water manholes and valve boxes; removing and installing grated drop inlets, pavement markings and traffic signs; and cleaning existing culverts and drainage structures.
- 2. The Contractor is reminded of the requirements of Subsection 105.16 Subcontracts.
- 3. The Contractor's attention is directed to the following Sections of the Special Provisions: Subsection 107.06 Contractor Duty Regarding Public Convenience; Subsection 104.11 Utilities and Services; and Section 645 Work Zone Traffic Control.
- 4. At the end of each day's work, the Contractor shall remove all equipment and other obstructions to permit free and safe passage of public traffic.
- 5. The existence and location of underground utilities, manholes, monuments and structures as shown on the plans are from the latest available data but the accuracy is not guaranteed. The encountering of other obstacles during the course of work is possible. The Contractor shall be held liable for any damages incurred to the existing facilities and/or improvements as a result of his operations.
- 6. The exact locations and limits or areas to be excavated, reconstructed and cold planed shall be determined in the field by the Engineer.
- 7. All paving works including cold planing, pavement reconstruction, and resurfacing shall be done at night, except for the period from September 15, 2009 to December 31, 2009. During this period, paving works may be done during daytime working hours. Night time working hours are specified in Subsection 107.03 of the Special Provisions.

Daytime operations and working hours are also specified in Subsection 107.03 of the Special Provisions.

- 8. The Contractor shall notify the Engineer in writing, two (2) weeks prior to starting paving operations.
- 9. The Contractor shall remove and dispose of all existing raised pavement markers and traffic tapes prior to the overlaying of Asphalt Concrete. This work shall be considered incidental to Hot Mix Asphalt Pavement, Mix No. IV and will not be paid for separately.
- 10. All holes, depressions and wheel ruts shall be filled and compacted with Hot Mix Asphalt Pavement, Mix No. V prior to resurfacing. This work will be paid for under Hot Mix Asphalt Pavement, Mix No. IV.
- 11. Smooth riding connections shall be constructed at all limits of resurfacing, including the beginning and end of project, connecting approaches, side streets and driveways as shown on the plans.
- 12. Trimming and dressing of shoulder, sidewalk and bus turnout shall consist of clearing, grubbing, grading, reshaping and compacting the unpaved shoulders with suitable material as shown on the plans and/or as directed by the Engineer. Suitable materials shall include materials from roadway excavation, including topsoil and base material therefrom, and if necessary, additional materials from borrow outside the limits of the right of way. Asphalt concrete removed from cold planing, reconstruction and roadway excavation shall not be used for dressing of shoulder, sidewalk or bus turnout. This work shall be considered incidental to the various contract items.
- 13. Earth swale shall be graded to drain. Graded swales shall be grassed. This work shall be considered incidental to the various contract items.
- 14. Existing drainage system will be functional at all times during construction. The Contractor shall furnish materials, equipment, labor, tools and incidentals necessary to maintain flow. This work shall be considered incidental to various contract items.

- 15. The Contractor shall provide for access to and from all existing driveways, sidewalks and ADA access routes, and side streets and cross streets at all times. This work shall be considered incidental to the various contract items, and will not be paid for separately.
- 16. All saw cutting work shall be considered incidental to Hot Mix Asphalt Pavement, Mix No. IV and will not be paid for separately.
- 17. Prior to his resurfacing operations, the Contractor shall be responsible for locating, preserving and marking all utility \$\psi\$ highway facilities that will require adjustments to the new finished pavement grade. Additionally, the Contractor shall submit to the Engineer a list of all items, including water, drainage, sewer, electrical, telephone and cable utilities to be adjusted to the new finished grade.
- 18. After completion of resurfacing, the Contractor and the Engineer will test for, and determine ponding areas (i.e. low spots within the resurfaced area). It shall be the responsibility of the Contractor to correct and resurface and/or repair all such ponding areas.
- 19. Contractor shall exercise extreme caution to preserve BENCHMARKS (Survey Monuments). Whenever the center of a Survey Monument is less than three (3) feet from the edge of construction, the Contractor shall retain a Licensed Land Surveyor to reference the location of said Survey Monument.

Benchmarks that are disturbed or destroyed shall be restored under a Licensed Land Surveyor's direction. Copies of field notes, descriptions and new values of the new benchmark shall be sent to the Department of Transportation, Highways Division, Cadastral Engineering Section, for review and approval prior to construction.

- 20. Install new Type II Object Marker on all utility poles and trees that are shown on Plan Sheets 15, 16 and 17. Refer to Standard Plan TE-17 for details.
- 21. All asphalt concrete materials from cold planing, reconstruction and roadway excavation operations shall become the property of the Contractor. The Contractor shall remove and dispose these materials at no cost to the State.
- 22. Any work specified in the contract but not listed separately in the proposal schedule shall be considered incidental to other various contract items and shall not be paid for separately.
- 23. No material and/or equipment shall be stockpiled or otherwise stored within the highway right-of-way except at locations designated in writing and approved by the Engineer. If use of location is approved by the Engineer, the Contractor shall obtain a permit to use the property within the highway right-of-way from the State Highways Division at telephone no. 241-3000.
- 24. The Contractor will be required to locate all existing water valve boxes and manholes, including ones that may have been inadvertently paved over on previous resurfacing projects, by scheduling an on-site field reconnaisance with the Department of Water Operations Division prior to any resurfacing work Phone No. 245-5434. Failure to meet this requirement will subject the Contractor to all future costs involved in locating and raising any affected water valve boxes and manholes. Approximate locations of valve boxes and manholes that are to be raised to the new finished grade are noted on the plans.

It shall be the responsibility of the Contractor to offset and record the locations of the valve boxes and manholes as marked by the Department of Water for purposes of adjusting the valve boxes and manholes to the new finished grades after completion of his resurfacing operations. The Contractor shall preserve all offset stakes marking the locations of the valve boxes and manholes. If offset stakes are damaged or lost, it shall be the Contractor's sole responsibility to re-stake locations of the valve boxes and manholes.

25.
