- 2. CAUTION SHALL BE EXERCISED SO THAT EXISTING AREAS TO REMAIN SHALL NOT BE DAMAGED. THE CONTRACTOR SHALL BE RESPONSIBLE FOR ANY AND ALL CORRECTIVE WORK REQUIRED TO RESTORE ALL DAMAGED ITEMS TO THEIR ORIGINAL OR NEW CONDITION AS OCCURS.
- 3. ALL UNUSABLE DEBRIS AND WASTE SHALL BE HAULED AWAY TO AN APPROPRIATE OFF-SITE DUMP AREA. DURING LOADING OPERATIONS, DEBRIS AND WASTE MATERIALS SHALL BE WATERED DOWN TO ALLAY DUST.

PRIOR TO THE NOTICE TO PROCEED FOR CONSTRUCTION; NO LATER THAN 20 WORKING DAYS BEFORE THE ACTUAL COMMENCEMENT OF ANY ON-SITE CONSTRUCTION ACTIVITY: A WRITTEN NOTIFICATION OF THE PROPOSED ASBESTOS ABATEMENT WORK SHALL BE SENT TO THE STATE OF HAWAII, DEPARTMENT OF HEALTH, AND TO OTHER GOVERNMENT AGENCIES RESPONSIBLE FOR OCCUPATIONAL HEALTH AND SAFETY, HAZARDOUS WASTE DISPOSAL. AND AUTHORITIES -RESPONSIBLE FOR THE ENFORCEMENT OF THE NATIONAL-EMISSION STANDARD FOR ASBESTOS

12. PRIOR TO THE NOTICE TO PROCEED FOR CONSTRUCTION, A PRE-CONSTRUCTION MEETING WILL BE HELD WITH THE CONTRACTOR. IN THE MEETING THE CONTRACTOR SHALL DISCLOSE AND IDENTIFY ALL CONTROL AND RESTRICTED AREAS, DESIGNATED HAULING ROUTES WITHIN THE BUILDING, LOADING AND UNLOADING AREAS, ASBESTOS STAGING AREAS, HOURS OF WORK, AND ADDRESS ALL CONCERNS TO INSURE THE PROPER AND SAFE EXECUTION OF WORK.


