A compact disc containing the plans, specifications, proposal and contract forms may be obtained from the above offices. Bids (hard copies) shall be submitted in a sealed envelope, and shall be on the Proposal Form provided on the compact disc furnished by said Department. Bids received after the established due date and time will not be considered.

The project includes application of slurry seal over the existing asphalt concrete pavement, installation of pavement markings and striping, installation of reflector markers on existing guardrails, and the cleaning of existing culverts and drainage structures. Estimated construction cost is between \$500,000 and \$1,000,000.

To be eligible for award, bidders must possess a valid State of Hawaii General Engineering Contractor's "A" license or Specialty Contractor's "C-3" or "C-3a" license, prior to bidding.

The Hawaii Products Preference pursuant to ACT 175, SLH 2009 is applicable to this project. Persons wishing to certify and qualify a product as a Hawaii Product shall submit a Certification for Hawaii Product Preference (SPO Form 38) to the Department of Transportation Contracts Office no later than 4:30 p.m., fourteen (14) calendar days prior to the bid opening date. Late submittals for this project will not be reviewed by the Department.
