A compact disc containing the plans, specifications, proposal and contract forms may be obtained from the above offices. Bids (hard copies) shall be submitted in a sealed envelope, and shall be on the Proposal Form provided on the compact disc furnished by said Department. Bids received after the established due date and time will not be considered.

The project includes application of slurry seal over the existing asphalt concrete pavement, installation of pavement markings and striping, installation of reflector markers on existing guardrails, and the cleaning of existing culverts and drainage structures. Estimated construction cost is between \$1,000,000 and \$5,000,000.

To be eligible for award, bidders must possess a valid State of Hawaii General Engineering Contractor's "A" license or a Specialty Contractor's "C-3" or "C-3a" license, prior to the award of the contract.

A pre-bid conference is set for 11:00 a.m., June 1, 2009, at the Department of Transportation, Highways Division, Maui District Office Conference Room, 650 Palapala Drive, Kahului, Hawaii. All prospective bidders or their representatives (employees) are encouraged to attend, but attendance is not mandatory.

Campaign contributions by State and County Contractors. 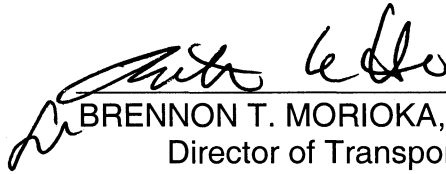

Additionally, Bidders are directed to read the American Recovery and Reinvestment Act (ARRA) Special Provisions which require monthly employment reporting of the general contractor and its subcontractors. Bidders are advised of the shortened Award duration specified in Special Provision Section 103.02, the shortened Notice to Proceed date in Section 108.01, and the authority of the U.S. Comptroller General or Inspector General to interview the contractor or its

subcontractor's employees or officers, or to examine project records in Section 107.17.
