- This is an Invitation for Bid project for Guardrail Repairs and Maintenance at Various Locations on the island of Maui. The Repairs and Maintenance of these Guardrails are along State Highways in four (4) areas of coverage: Central Maui, Upcountry Maui, Lahaina, and Hana. Please refer to Special Provisions Section 110 –Guardrail Repairs and Replacement at Various Locations for the list of corresponding State Highways covered in this project.
- The scope of work consists of performing immediate guardrail repairs and replacements required to maintain the public roadways in a safe and usable condition at all times. Such guardrail repair and replacement work shall not include any new (initial) guardrail installations at any location of the roadways.
- Proposal Schedule items show the approximate quantity for each pay item. Amounts for each pay item will be calculated by multiplying the unit price by the approximate quantity. The unit price will be the amount used to compare bids and select a low bidder.
