Bids (hard copies) shall be submitted in a sealed envelope, and shall be on the Proposal Form provided on the compact disc furnished by said Department. Bids received after the established due date and time will not be considered.

The project consists of reconstructing of weakened pavement, applying crack seal and paving grid to the affected areas, cold planing, adjustment of survey monuments and utility frames and covers, resurfacing of existing asphalt concrete pavement, installation of pavement markings and striping, installation of reflector markers on existing guardrails, and the cleaning of existing culverts and drainage structures.

Estimated construction cost is between \$1,000,000 and \$5,000,000

To be eligible to award, bidders must possess a valid State of Hawaii General Engineering Contractor's "A" license or General Building Contractor's "B" license or Specialty Contractor's "C-3 or "C-3a license, prior to the award of the contract.

A pre-bid conference is set for 10:00 A.M., October 25, 2011, at the Department of Transportation, Maui District Office, 650 Palapala Drive, Conference Room, Kahului, Hawaii 96732. All prospective bidders or their representatives (employees) are encouraged to attend, but attendance is not mandatory.
