MINUTES OF THE MEETING:

Items of Discussion:

- 1. The meeting was opened by DOT-M with introductions of all attendees present at the meeting.
- 2. DOT-M presented the general scope of work consisting of the replacement of the existing concrete wall, upgrading of guardrails and pavement markings.
- 3. Contractors were informed that RFIs will not be entertained after November 6, 2014.
- 4. Contractors questions with responses as follows:

Contractor's questions:

1. Are the Portable Concrete Barriers to be furnished by the State or is the Contractor responsible to procure?

Response: Contractor is responsible for procuring the Portable Concrete Barriers. See Proposal Schedule.

2. Please provide details for the leading the leading Water Filled Barrier.

Response: See Note 2 on Plan Sheet ADD. 15.

3. Item No. 631.0100 – Regulatory Sign (10 Square Feet or Less), what signs shown on sheet No.1 of 1 of the Signing & Traffic Control Plan is to be paid for in the bid item?

Response: See Plan Sheet ADD. 15.

4. The Signs and Posts shown on the drawing refer to Traffic Control Plan. Do these signs and posts get paid for in item No. 645.0100 – Traffic Control?

Response: YES.

5. The A.C. Pavement Reconstruction Detail on Sheet 1 of 1 of the typical Sections and Details shows a 6" Aggregate Subbase Layer. There is no Bid Item provided in the Proposal.

Response: The 6" Aggregate is incidental to Hot Mix Glasshhalt. See Note 16 on Plan Sheet 3.

6. Item No. 696.0000 – Field Office and Project Site Laboratory (Not to Exceed \$32,000.00), what are the requirements? If the requirements are as what stated in the Standard Specifications for Road and Bridge Construction, the not to exceed \$32,000.00 is not enough.

Response: The \$32,000.00 not to exceed amount is non-negotiable.

7. Can the 19% UDBE goal be reassessed? The only subcontractors that are available for this work are Reinforcing Steel. The projected contract amount would be about \$250,000.00 which would only be 10% of a possible \$2,500,000.00.

Response: The UDBE goal was reconsidered but will remain as is.

8. This is a discrepancy between page 13 Low Speed Undivided Highway Work Zone Signing Plan and Page 15 Signing & Traffic Control Plan. The signing required for the Low Speed Undivided Highway Work Zone has more signing required than the signing required for the Signing & Traffic Control plan. Which governs?

Response: Plan Sheet 13 is the Typical Detail for Construction Signs on Two Lane or Multilane Undivided Low Speed Highway where Plan Sheet ADD.15 is the Traffic Control Plan for the Actual Work Zone Area. See Note 1 on Plan Sheet ADD.15.
