The project includes reconstructing weakened pavement areas, cold planing roadway surfaces, resurfacing, installing new guardrails and terminals, installing new grated drop inlets, cleaning existing culverts, installing signs, pavement marking and striping and all incidentals necessary to complete this resurfacing work.

Plans and specifications may be examined and borrowed at the appropriate offices. Borrowed plans and specifications shall be returned in good condition within 30 calendar days after the bid opening date.

To be eligible to bid, bidders must possess a valid State of Hawaii General Engineering Contractor's "A" license.

Bidder's notice of intention to bid must be received at said Contracts Office no later than 4:30 P.M., 10 calendar days prior to the bid opening date. If the tenth day is on a Saturday, Sunday or State holiday, the notice of intention is due on the last working day prior to the due date. Fax notice is acceptable

provided the Contracts Office receives the faxed notice within the time stated above. The fax number is (808) 587-2132. It is the bidder's responsibility to ensure that the Contracts Office receives the notice of intent on time and in a legible condition.

The Department of Transportation, in accordance with the provisions of Title VI of the Civil Rights Act of 1964 (78 Stat. 252) and the Regulations of the U.S. Department of Transportation (Title 49, Code of Federal Regulations Part 21) issued pursuant to such Act, hereby notifies all bidders that it will affirmatively insure that the contract entered into pursuant to this advertisement will be awarded to the lowest responsible bidder without discrimination on the grounds of race, color, religion, sex, national origin, age, or disability.


Each proposal shall be on a form furnished by said Department.
