A compact disc containing the plans, specifications, proposal, contract forms may be obtained from the above offices. Bids (hard copies) shall be submitted in a sealed envelope, and shall be on the Proposal Form provided on the compact disc furnished by said Department. Bids received after the established due date and time will not be considered.

The project includes cold planing existing pavement, reconstruction of weakened pavement areas, overlay of 2 inch Hot Mix Asphalt Pavement, installing pavement markings, installing guardrail Type 3 Strong Post W-beam and end terminals, installing milled rumble strip, installing enhanced vehicle classification counting system, applying longitudinal joint stabilizer, adjusting centerline and reference monuments, and cleaning

storm drain within the project limits. Estimated construction cost is between \$5,000,000 and \$10,000,000.

To be eligible for award, bidders must possess a valid State of Hawaii General Engineering Contractor's "A" license at the time of bidding.

The Hawaii Products Preference pursuant to Act 175, SLH 2009, is applicable to this project. Persons wishing to certify and qualify a product as a Hawaii Product shall submit a Certification for Hawaii Product Preference (SPO-Form 38) to the DOT Contracts office no later than 4:30 p.m., fourteen (14) calendar days prior to the bid opening date. Late submittals for this project will not be reviewed by the DOT. A separate SPO-Form 38 shall be completed and submitted for each product. A 5% bid adjustment for bidders that are parties to apprenticeship agreements pursuant to Section 103-55.6, Hawaii Revised Statutes (HRS), is applicable to this project.

Compliance with Act 192, SLH 2011 is a requirement whereby a minimum of 80% of the bidder's work force on this project **must** consist of Hawaii residents.

A pre-bid conference is set for 10:00 a.m., November 15, 2017, at the Department of Transportation, Highways Division, Maui District Office, 650 Palapala Drive, Kahului, Hawaii 96732.

All prospective bidders or their representatives (employees) are encouraged to attend, but attendance is not mandatory. Persons needing special accommodations at the pre-bid conference
