Bids (hard copies) shall be submitted in a sealed envelope, and shall be on the Proposal Form provided on the compact disc furnished by said Department. Bids received after the established due date and time will not be considered.

The project consists of reconstruction of weakened pavement, cold planing, 1 1/2 inch resurfacing of existing asphalt concrete pavement, utility adjustment, installation of pavement markings and striping, installation of reflector markers on existing guardrails, and the cleaning of existing culverts and drainage structures. Estimated construction cost is between \$1,000,000 and \$5,000,000.

To be eligible for award, bidders must possess a valid State of Hawaii General Engineering Contractor's "A" license or Specialty Contractor's "C-3" or "C-3a" license, prior to the award of the contract.

A pre-bid conference is set for 10:00 A.M., June 3, 2011, at the Department of Transportation, Highways Division, Maui District Office Conference Room, 650 Palapala Drive, Kahului, Hawaii 96732. All prospective bidders or their representatives (employees) are encouraged to attend, but attendance is not mandatory.
