1. Can you close lanes?

Response: Yes. You may do lane closures during off-peak hours from 8:30am to 3:00pm as noted in the bid documents.

2. Is there staging area space around the pullouts.

Response: Yes. The selected spots are wide shoulder areas that the downhill bicycle tour vans already stop and rest at.

Introduction (by STATE)

SCOPE OF WORK:

The project involves constructing paved shoulder pullouts at four (4) spot locations along Haleakala Crater Road (Route 378). The locations of the pullouts are at approximate Mile Posts 3.00, 4.00, 4.37. & 7.00. The scope of work consists of some sawcutting & removal of pavement, excavating, placing base & fill material, asphalt paving, shoulder dressing, and installing pavement markings.

The Contractor's attention is directed to the requirements of:

Special Provisions

Subsection 105.16 (A) Subcontract Requirements. Contractor shall perform with his/her own organization work amounting to not less than 30% of the total contract cost, except "Specialty Items" as listed in Special Provision pages 105-2a and 105-3a.

Subsection 108.08 – Liquidated Damages for failure to complete work on time is \$1,200 per working day.

Subsection 108.09 – Rental Fees for Unauthorized Lane Closure or Occupancy is \$500 for every fifteen minute increment per lane not to exceed \$5,500 per day.

Section 212 – Archaeological Monitoring; Contractor shall obtain the services of a qualified archaeological firm to create an archaeological monitoring plan that will addresss incorporating any historic properties which might be encountered during construction activities into the Programatic Agreement (PA) survey planned for the Advance Technology Solar Telescope Project at the Haleakala Crater summit. Refer to August 22, 2011 State Historic Preservation Division letter inserted before the Proposal pages.

This is a federally aided project and all requirements as noted in the Special Provisions apply to the general contractor and subcontractors. Form FHWA-1273 (Rev.3-94) and Supplement to the Federal Form FHWA-1273 must be physically incorporated in all of the subcontractor agreements.

Proposal Schedule

Page 8 of the Proposal Schedule has errors in the approximate quantities for Items 312.0100 Hot Mix Glassphalt Base Course and 401.0400 HMA Pavement, Mix No.IV. Corrected quantities of 230 Tons and 160 Tons respectively, will be reflected on a new Proposal page to be distributed by Addendum No. 1.

Standard Specifications

Subsection 107.04 Overtime and Night Work. The contract Standard Specifications state that "Overtime and nighttime work are permissible when approved by the Engineer in writing…" However, due to concerns expressed by the US Fish and Wildlife Service regarding nighttime lighting disorienting seabirds, no nighttime work will be permitted.
