The project includes constructing reinforced concrete foundations and floor slabs, concrete unit masonry walls, steel frame building, metal decking, standing seam steel roofing, roof insulation, flashing and sheet metal, doors, rolling service doors, metal wall louvers, architectural finishes, building specialties, plumbing, compressed air system, window air conditioning unit, lubrication hose reels, electrical work and incidental related work. Site work includes clearing and grubbing, demolition, constructing recycling system equipment enclosure, vehicle wash down area, underground collection pit/separator, underground sump pit/catch basin, open material storage, concrete apron and ramp, asphalt concrete parking area, chain link fence gate, water and sanitary sewerage connections, electrical distribution, landscaping, and miscellaneous site improvements.

Plans and specifications may be examined and borrowed at the appropriate offices. Borrowed plans and specifications shall be returned in good condition within 30 calendar days after the bid opening date.

To be eligible to bid, bidders must possess a valid State of Hawaii General Building Contractor's "B" License.

The Department of Transportation, in accordance with the provisions of Title VI of the Civil Rights Act of 1964 (78 Stat. 252) and the Regulations of the U.S. Department of Transportation (Title 49, Code of Federal Regulations Part 21) issued pursuant to such Act, hereby notifies all bidders that it will affirmatively insure that the contract entered into pursuant to this advertisement will be awarded to the lowest responsible bidder without discrimination on the grounds of race, color, religion, sex, national origin, age, or disability.

Each proposal shall be on a form furnished by said Department.

Estimated construction cost is between \$1 million - \$5 million.
