The Hawaii Department of Transportation (HDOT) is soliciting proposals to provide support and installation services to upgrade the existing communication system for the H-3 Intelligent Transportation System. Sealed Proposals will be received at the Contracts Office, Department of Transportation, 869 Punchbowl Street, Honolulu, Hawaii 96813, until 2:00 p.m., Hawaii Standard Time (HST), on December 8, 2011.

Offerors will be responsible for replacement of communications equipment and testing of the existing fiber network at the existing 15 communications hubs at the H-3 Tetsuo Harano Tunnels and approaches to the tunnels on Interstate Route H-3.

A pre-proposal conference will be held on October 26, 2011 at 9:00 AM in the conference room at the H-3 TOC located at the H-3 Halawa portal building. All prospective Offerors are encouraged to attend but attendance is not mandatory. A walk-through to allow potential Offerors a view of typical Hub locations will follow the conference. Limited facilities are available for the conference and walk-through. Representation will be limited to two (2) individuals per Offeror team.
