- 5. All light fixtures and nodes will be reused and shall be reintegrated into the existing light grid network. The Contractor shall confirm the lights show up on the grid and are fully operational and functioning.
- 6. The Contractor shall coordinate with Matson regarding existing communication equipment mounted on light poles and pedestals.

  Removal and reinstallation of equipment will be performed by Matson.
- 7. The estimated cost is \$1,000,000 to \$1,500,000.
