


Note: Existing Asphalt Pavement on bridge deck is 3/4"- 1" thick.

AIEA I.C. STRUCTURE NO. 2 Not to Scale




LONGITUDINAL SECTION AIEA I.C. STRUCTURE NO. 2 Not to Scale

- 1. The scope of work for this project consists of cold planing and resurfacing the existing bridges, repairing deck joints and installing pavement markers and striping.
- 2. The Contractor's attention is directed to Subsection 107.13-" Public Convenience and Safety" and to Section 645-"Traffic Control" of the Special Provisions.
- 3. The Contractor shall notify the Mass Transit Line, Inc. Customer and Public Relations Office at 537-9224 seven (7) days prior to any paving operations.
- 4. The existence and location of underground utilities, manholes, monuments and structures as shown on the plans are from the latest available data but accuracy is not guaranteed. The encountering of other obstacles during the course of the work may be possible. The Contractor shall be held liable for any damages incurred to the existing facilities as a result of his operations. All damaged portions shall be replaced in accordance with the Standards and Specifications of the State and/or the affected utility company.
- 5. As shown on the plans or as directed by the Engineer, a smooth riding transition shall be provided at the beginning and end of the resurfaced structures.
- 6. All the existing Asphalt Concrete shall be removed from the structure decks prior to resurfacing. In addition to removal of all the existing Asphalt Concrete on Aiea I.C. Structure No. 2, the Contractor shall cold plane the high spots of the concrete deck to a depth of not more than 1/4" as directed by the Engineer. The Contractor shall exercise extreme caution in his operations not to exceed the 1/4" limit. This work shall be considered incidental to "Cold Plane Existing Pavement on Aiea I.C. Structure No. 2".
- 8. All the structures shall be resurfaced with # Asphalt Concrete Pavement Mix No I. as shown in the Typical Sections.
