

NOTICE TO BIDDERS
(Chapter 103D, HRS)

The receiving of SEALED BIDS for **INSTALLATION OF ENHANCED PAVEMENT MARKING AND NEW MILLED RUMBLE STRIP AT VARIOUS LOCATIONS, OAHU, FEDERAL-AID PROJECT NO. HSIP-0300(191)**, will begin as advertised on April 14, 2022 in HiePRO. Bidders are to register and submit bids through HiePro only. Deadline to submit bids is Bid Opening Day, May 19, 2022 at 2:00pm Hawaii Standard Time (HST). Bids received after said due date and time shall not be considered.

The contract includes pavement marking and rumble strip installation on the island of Oahu on an “as-needed” basis.

To be eligible for award, bidders must possess a valid State of Hawaii General Engineering Contractor’s “A” or Specialty Contractor’s “C-3” or “C-3a” license, prior to the award of contract.

A pre-bid conference is scheduled for April 27, 2022 at 10:00am. All prospective bidders or their representatives (employees) are encouraged to attend, but attendance is not mandatory. Due to the impacts of COVID 19, the pre-bid meeting will be conducted virtually. Questions applicable to the Project Specifications should be submitted to the Project Manager no later than two days prior to the scheduled date of the pre-bid meeting. ALL requests for information (RFI) shall be received in writing via HiePRO no less than 14 calendar days before bid opening. Questions received after the deadline will not be

addressed. Verbal requests for information will not receive a response. Anything said at the conference is for clarification purposes and any changes to the bid documents will be made by addendum and posted in HlePRO.

Any protest of this solicitation shall be submitted in writing to the Director of Transportation, in accordance with §103D-701, HRS and §3-126, HAR.

Campaign contributions by State and County Contractors. Contractors are hereby notified of the applicability of Section 11-355, HRS, which states that campaign contributions are prohibited from specified State or county government contractors during the term of the contract if the contractors are paid with funds appropriated by the legislative body. The U.S. Department of Transportation Regulation entitled “Nondiscrimination in Federally-Assisted Programs of the U.S. Department of Transportation,” Title 49, Code of Federal Regulations (CFR), Part 21 is applicable to this project. The U.S. Department of Transportation Regulations entitled "Participation by Disadvantaged Business Enterprise in Department of Transportation Programs", Title 49, Code of Federal Regulations, Part 26 is applicable to this project. Bidders are hereby notified that the Department of Transportation will strictly enforce full compliance with all of the

requirements of the Small Business Enterprise (SBE) program with respect to this project.

Bidders are directed to read and be familiar with the Small Business Enterprise (SBE) Requirements, which establishes the program requirements pursuant to Title 49 Code of Federal Regulations Part 26 and, particularly, the requirements of certification, method of award, and evidence of good faith.
