## PRE-BID MEETING MINUTES JUNE 1, 2011

The following minutes are from the Hawaii Department of Transportation (HDOT) pre-bid meeting with prospective bidders for the Sidewalk Repairs at Various Locations on Oahu project.

The meeting was held at the State Office Building in Kapolei, Room 609 at 1:30 pm.

#### Questions:

- Will HDOT require a separate bond for each work order?
  - No. Bonds are for the contract year.
- 2. When will the Notice to Proceed be issued?
  - Work would start near the end of this year. November at the earliest.
- 3. Is the contract work for sidewalks only? Does it include replacing curbs, adjusting utility boxes or curb ramps, etc.?
  - Work is to replace sidewalks only. It does not include other replacements or adjustments.
- 4. Does the sidewalk cost include new bed course? Or is the existing bed course recompacted and reused?
  - According to the special provisions, new bed course is included in the price of the sidewalk.
- 5. Does the cost include dowelling and drilling?

Yes.

6. Is there a required and/or minimum size for the electronic message boards?

HDOT uses large boards on multi-lane roadways and freeways and smaller boards on secondary roadways.

7. Does the contract period of 12 months apply to each area or is it divided between the four areas?

The contract time of 12 months applies to each area.

8. What is the budget for this project? How much was spent on the last contract?

There is no set budget for this project. We don't know how much was spent on the last contract.

9. Will the Contractor have to get any permits?

Yes, depending on where the work is located.

10. Who issues the work orders?

The Field Engineer from the Oahu District Office.

11. Will each work order be for the same amount of work?

No. The amount of work can vary.

12. Does work include demolishing existing curbs?

No.
