The project includes cold planing, resurfacing, reconstruction of weakened pavement areas, adjusting utility box frames, manholes and covers, replacing signs and reflector markers, installing pavement markings, replacing and/or reconstructing sidewalks and curb ramps, replacing guardrails, end treatments and bridge railings, replacing existing highway lighting systems, drainage system improvements, and bridge deck strengthening.

Plans and specifications may be examined and borrowed at the appropriate offices. Borrowed plans and specifications shall be returned in good condition within 30 calendar days after the bid opening date.

A pre-bid conference is set for 9:30 a.m., September 7, 2005, at the Department of Transportation, Highways Division, 601 Kamokila Boulevard, Room 333, Kapolei, Hawaii 96707. All prospective bidders or their

representatives (employees) are encouraged to attend, but attendance is not mandatory.

To be eligible to bid, bidders must possess a valid State of Hawaii General Engineering Contractor's "A" license.

Bidders are hereby notified that the Department of Transportation will affirmatively ensure that the contract entered into pursuant to this advertisement will be awarded to the lowest responsible bidder without discrimination on the grounds of race, color, national origin and sex (as directed by 23 CFR Part 200).


