established due date and time will not be considered.

**The project includes slope surface preparation; installation of
articulated concrete block mat; clearing of vegetation; recontouring by
grading and shaving existing cut slopes; installation of anchored geogrid
system; hydro-mulch seeding; planting; maintaining of vegetation during
plant establishment period, erosion control BMP's; and providing traffic
control.** Estimated construction cost is between \$1,000,000 and \$5,000,000.

To be eligible for award, bidders must possess a valid State of Hawaii
General Engineering Contractor's "A" license, at the time of bidding.

In accordance with Section 3-124-4, Hawaii Administrative Rules, this project is subject to Hawaii Product Preference.
