A compact disc containing the plans, specifications, proposal, contract forms, and applicable National Pollutant Discharge Elimination System (NPDES) Permit documents, may be obtained from the above office. Bids (hard copies) shall be submitted in a sealed envelope, and shall be on the Proposal Form provided on the compact disc furnished by said Department. Bids received after the established due date and time will not be considered.

The project includes slope surface preparation; clearing of vegetation; recontouring by shaving existing slopes; planting; hydro-mulching; installation of erosion control matting; installation and maintenance of temporary erosion control BMP's; and providing traffic control. Estimated construction cost is between \$2,000,000 and \$3,000,000.

To be eligible to bid, bidders must possess a valid State of Hawaii General Engineering Contractor's "A" license, prior to bidding.

The Hawaii Products Preference pursuant to Act 175, SLH 2009, is applicable to this project. Persons wishing to certify and qualify a product as a Hawaii Product shall submit a Certification for Hawaii Product Preference (SPO - Form 38) to the DOT Contracts office no later than 4:30 P.M., fourteen (14) calendar days prior to the bid opening date. Late submittals for this project will not be reviewed by the DOT. A separate SPO-Form 38 shall be completed and submitted for each product. A 5% bid adjustment for bidders that are parties to apprenticeship agreements pursuant to Section 103-55.6, Hawaii Revised Statutes (HRS), is applicable to this project.

Compliance with Act 192, SLH 2011 is a requirement whereby a minimum of 80% of the bidder's work force on this project **must** consist of Hawaii residents.

A pre-bid conference is set for 9:00 A. M, November 5, 2015, at the Department of Transportation, Highways Division, Kakuhihewa Building, 601 Kamokila Boulevard, Room 609, Kapolei, Hawaii 96707. All prospective bidders or their representatives (employees) are encouraged to attend, but attendance is not mandatory. Anything said at the conference is for clarification purposes and any changes in the bid documents will be made by addendum.
