A compact disc containing the plans, specifications, proposal, contract forms, and applicable National Pollutant Discharge Elimination System Permit documents, may be obtained from the above office. Bids (hard copies) shall be submitted in a sealed envelope, and shall be on the Proposal Form provided on the compact disc furnished by said Department. Bids received after the established due date and time will not be considered.

**The project includes preparing the slope surfaces; clearing vegetation; re-contouring by shaving existing slopes; planting; hydro-mulching; installing erosion control matting; installing and maintaining temporary erosion control BMPs; and providing traffic control. Estimated construction cost is between \$2,000,000 and \$3,000,000.**

To be eligible for award, bidders must possess a valid State of Hawaii General Engineering Contractor's "A" license, prior to bidding.

The Hawaii Products Preference pursuant to Act 175, SLH 2009, is applicable to this project. Persons wishing to certify and qualify a product as a Hawaii Product shall submit a Certification for Hawaii Product Preference (SPO-Form 38) to the DOT Contracts office no later than 4:30 P.M., fourteen (14) calendar days prior to the bid opening date. Late submittals for this project will not be reviewed by the DOT. A separate SPO-Form 38 shall be completed and submitted for each product. Forms are available at <http://www.hawaii.gov/forms.com>.

A 5% bid adjustment for bidders that are parties to apprenticeship agreements pursuant to Section 103-55.6, Hawaii Revised Statutes (HRS), is applicable to this project.

Compliance with Act 192, SLH 2011 is a requirement whereby a minimum of 80% of the bidder's work force on this project **must** consist of Hawaii residents.

A pre-bid conference is set for 11:00 A.M., May 5, 2016, at the Department of Transportation, Highways Division, Kakuhikewa Building, 601 Kamokila Boulevard, Room 611, Kapolei, Hawaii 96707. All prospective bidders or their representatives (employees) are encouraged to attend, but attendance is not mandatory. Anything said at the conference is for clarification purposes and any changes in the bid documents will be made by addendum. 
