

A compact disc containing the plans, specifications, proposal, contract forms and applicable National Pollutant Discharge Elimination System (NPDES) permit documents may be obtained from the above offices. Bids (hard copies) shall be submitted in a sealed envelope, and shall be on the Proposal Form provided on the compact disc furnished by said Department. Bids received after the established due date and time will not be considered.

**The Base Proposal scope of work includes trenchless rehabilitation of corrugated metal and concrete culverts and debris removal; embankment slope improvements, and applying Best Management Practices. The Added Alternate No. 1 scope of work consists of trenchless rehabilitation of 72 inch diameter pipe and debris removal; embankment slope improvements, and applying Best Management Practices. The Added Alternate No. 2 scope of work consists of trenchless rehabilitation**

of 48 inch diameter pipe and debris removal; embankment slope improvements, and applying Best Management Practices. The Added Alternate No. 3 scope of work consists of trenchless rehabilitation of 24 inch diameter pipe and debris removal; embankment slope improvements, and applying Best Management Practices. Estimated construction cost is between \$6 million and \$7 million.

To be eligible to bid, bidders must possess a valid State of Hawaii General Engineering Contractor's "A" license.

The Hawaii Products Preference pursuant to Act 175, SLH 2009, is applicable to this project. Persons wishing to certify and qualify a product as a Hawaii Product shall submit a Certification for Hawaii Product Preference (SPO-Form 38) to the DOT Contracts office no later than 4:30 P.M., fourteen (14) calendar days prior to the bid opening date. Late submittals for this project will not be reviewed by the DOT. A separate SPO-Form 38 shall be completed and submitted for each product. A 5% bid adjustment for bidders that are parties to apprenticeship agreements pursuant to Section 103-55.6, Hawaii Revised Statutes (HRS), is applicable to this project.

Compliance with Act 68, SLH 2010 is a requirement whereby a minimum of 80% of the bidder's work force on this project **must** consist of Hawaii residents.

A pre-bid meeting at the Department of Transportation, Highway Division, Kakuhikewa Building, 601 Kamokila Blvd., Room 609, Kapolei, Hawaii 96707 is

set for June 5, 2018. All prospective bidders or their representatives (employees) are encouraged to attend, but attendance is not mandatory. ALL requests for information shall be received in writing (email is preferred) no less than ten (10) calendar days before bid opening so that the addendum can be processed and issued in a timely manner. Questions received after the deadline will not be addressed. Verbal requests for information will not receive a response. Anything said at the meeting is for clarification purposes and any changes to the bid documents will be made by addendum.

Any protest of this solicitation shall be submitted in writing to the Director of Transportation, in accordance with §103D-701, HRS and §3-126, HAR.


The Equal Employment Opportunity Regulations of the Secretary of Labor implementing Executive Order 11246, as amended, shall be complied with on this on this project.
