A compact disc containing the plans, specifications, proposal, contract forms, and applicable National Pollutant Discharge Elimination System Permit documents, may be obtained from the above office. Bids (hard copies) shall be submitted in a sealed envelope, and shall be on the Proposal Form provided on the compact disc furnished by said Department. Bids received after the established due date and time will not be considered.

**The project includes demolition and removal of existing asphalt pavement via cold planing or full depth reconstruction; application of seal coating on existing pavement; installation of asphalt pavement; installation of equipment shed and sampling equipment, hazardous material storage containers, erosion control matting, trench drain, concrete channel, and concrete water polisher; and installation and maintenance of temporary**

**and permanent BMPs.** Estimated construction cost is between \$1,000,000 and \$1,500,000.

To be eligible to bid, bidders must possess a valid State of Hawaii General Engineering Contractor's "A" license, prior to bidding.

The Hawaii Products Preference pursuant to Act 175, SLH 2009, is applicable to this project. Persons wishing to certify and qualify a product as a Hawaii Product shall submit a Certification for Hawaii Product Preference (SPO-Form 38) to the DOT Contracts office no later than 4:30 p.m., fourteen (14) calendar days prior to the bid opening date. Late submittals for this project will not be reviewed by the DOT. A separate SPO-Form 38 shall be completed and submitted for each product. A 5% bid adjustment for bidders that are parties to apprenticeship agreements pursuant to Section 103-55.6, Hawaii Revised Statutes (HRS), is applicable to this project.

Compliance with Act 192, SLH 2011 is a requirement whereby a minimum of 80% of the bidder's work force on this project **must** consist of Hawaii residents.

A pre-bid conference is set for 9:00 a.m. on May 9, 2018 at the Department of Transportation, Highways Division, Oahu District Office, 727 Kakoi Street, Honolulu, Hawaii 96819. All prospective bidders or their representatives (employees) are encouraged to attend, but attendance is not

mandatory. Anything said at the conference is for clarification purposes and any changes in the bid documents will be made by addendum. Contractors are hereby notified of the applicability of Section 11-355, HRS, which states that campaign contributions are prohibited from specified State or county government contractors during the term of the contract if the contractors are paid with funds appropriated by the legislative body. Any protest of this solicitation shall be submitted in writing to the Director of Transportation, in accordance with §103D-701, HRS and §3-126, HAR.
