5 The bidder's attention is directed to Sections 696 - Field Office and Project
6 Site Laboratory and 699 - Mobilization for the limitation of the amount bidders are
7 allowed to bid.

9 If the bid price for any proposal item having a maximum allowable bid
10 indicated therefore in any of the contract documents is in excess of such a
11 maximum amount, the bid price for such proposal item shall be adjusted to reflect
12 the limitation thereon. The comparison of bids to determine the successful bidder
13 and the amount of contract to be awarded shall be determined after such
14 adjustments are made, and such adjustments shall be binding upon the bidder.

16 The bidder is directed to Section 717 – Cullet and Cullet-Made Materials
17 regarding recycling of waste glass.

19 **Bidders shall submit and upload the complete proposal to HlePRO prior to**
20 **the bid opening date and time. Proposals received after said due date and**
21 **time shall not be considered.** Original (wet ink, hard copy) proposal documents
22 are not required to be submitted. **Contract award shall be based on evaluation**
23 **of proposals submitted and uploaded to HlePRO. Any additional support**
24 **documents explicitly designated as confidential and/or proprietary shall be**
25 **uploaded as a separate file to HlePRO. Do not include confidential and/or**
26 **proprietary documents with the proposal. The record of each bidder and**
27 **respective bid shall be open to public inspection.**

28 **FAILURE TO UPLOAD THE COMPLETE PROPOSAL TO HlePRO SHALL BE**
29 **GROUND FOR REJECTION OF THE BID.**

30 If there is a conflict between the specification document and the HlePRO
31 solicitation, the specifications shall govern and control, unless otherwise specified.
