- A. The pre-bid meeting was called to order by Seeyin Tommee (HDOT HWY-DB) at 10:00 a.m. Hawaii Standard Time (HST) to brief the prospective bidders for the subject project.
- B. Bidders were reminded, anything said at this meeting is for clarification only. The bid documents shall govern over anything said and discrepancies shall be clarified by addendum.
- C. Bidders were reminded that no questions would be allowed during this meeting. All questions or request for information (RFI) must be submitted in writing on HIePRO by Wednesday, January 24, 2024, at 2:00 p.m. HST. Emails will not be answered. Questions received after the deadline will not be addressed and verbal RFI's will not receive a response.
- D. Discussion of scope of work for project are construction of overhead sign structures; sign frames and drilled shaft; reconstructions of concrete barriers, glare screens, grading, installation of destination sign panels; pavement markings and modifications to the electrical conduits and pullboxes; and maintenance and removal of temporary erosion control measures and traffic control. The six overhead sign structures to be replaced are located on various routes on Oahu.
- E. Bidders were reminded that Disadvantage Business Enterprise (DBE) forms must be emailed to the project manager by Monday, February 22, 2024, at 2:00 p.m. HST. Failure to provide these documents shall be cause for bid/proposal rejection.

- F. Jesus Navarro (HDOT OCR) discussed DBE for this project and noted the following:
 - 1. The DBE Project Goal is 2.0%. Be sure to document discussions, phone calls, faxes or memos relating to your effects in meeting the DBE goal. DBEs must be certified by the bid opening date. DBE subcontractors, manufacturers, suppliers, trucking companies and any second-tier subcontractors shall be listed on the respective DBE forms in order to receive credit.
 - 2. The following forms are due to the Department's Project Manager or designee by the close of business, 4:30 p.m. HST, five (5) calendar days after bid opening. These forms are confidential documents and should not be included in the submitted proposals.
 - 3. BIDDER REGISTRATION FORM. All firms bidding or quoting on Hawaii Department of Transportation (HDOT) projects, including vendors, subcontractors, manufacturers, truckers, etc., must register as a bidder. Certified DBEs are automatically registered as a bidder with the HDOT. Can you please confirm that luminaries will not be required on all sign structures?

Response: There are no luminaires on the structures.

3. Is there a pre-bid meeting attendees list?

4. The electrical drawings show removal of existing ductlines and cables. Can we just remove the cables and remove only the portion of the ductline that is in conflict with the new work and abandon the rest? Or do we need to remove the entire ductline that is designated for removal? Please advise. Also, there is no bid item for ductline removal. Please add a bid item for it.

Response: The ductline shall be removed as shown on the plans. The demolition and excavation as well as the restoration of the area shall be considered incidental to the various pay items. All areas affected by the removal of the ductlines shall be restored to its original condition.

5. Are there any borings for sign Structure H201R-874? and also for sign structure H1EB-260? Didn't find the borings info in the geotechnical report

Response: There are no borings for these locations.

6. Will there be any opportunity to request for clarification on the RFI responses since the RFI due date has already passed?
